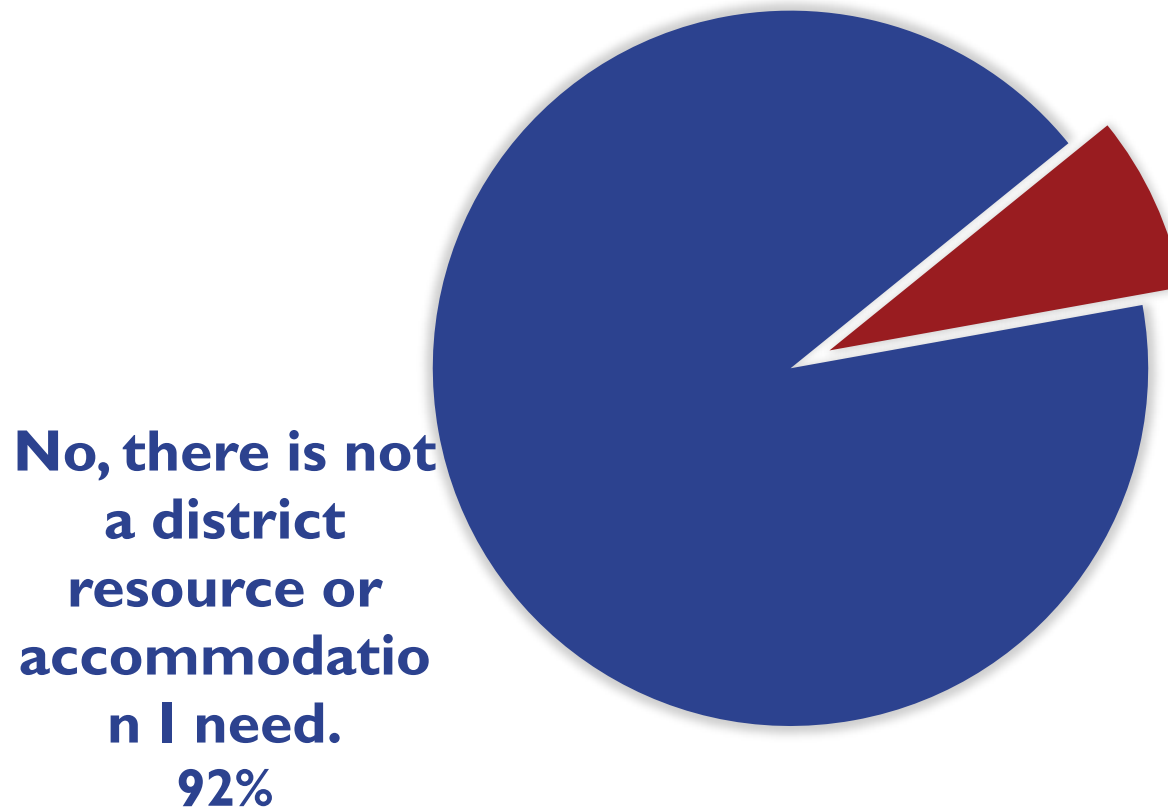

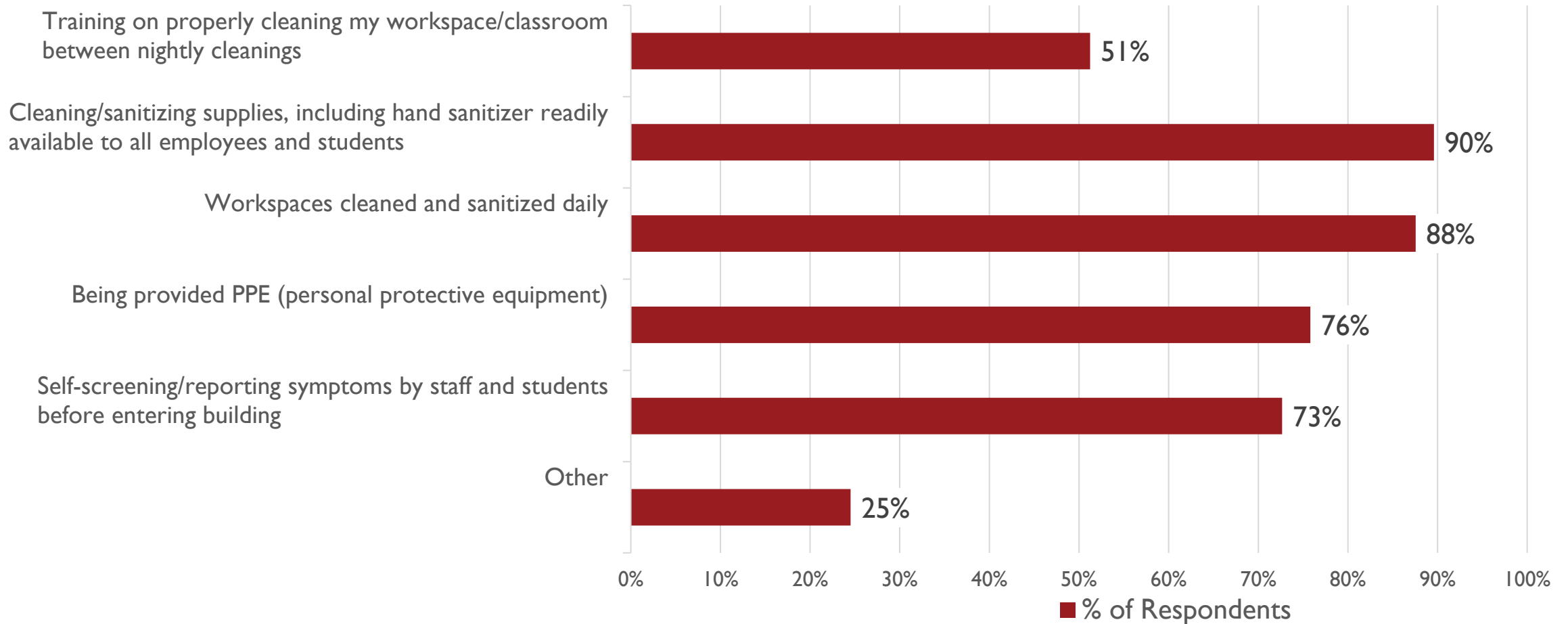

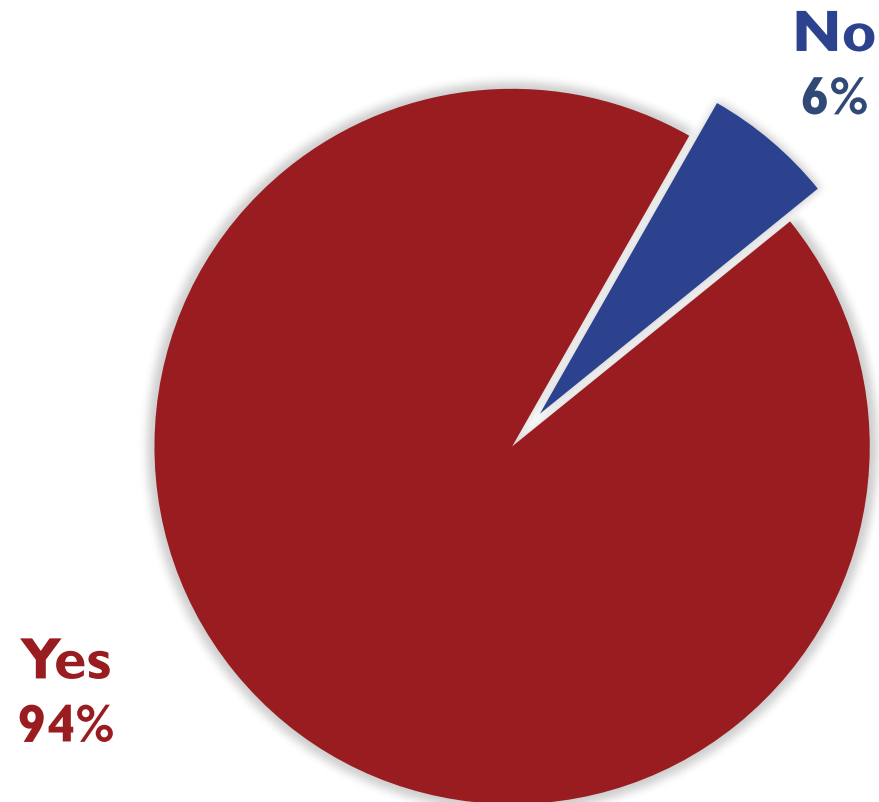

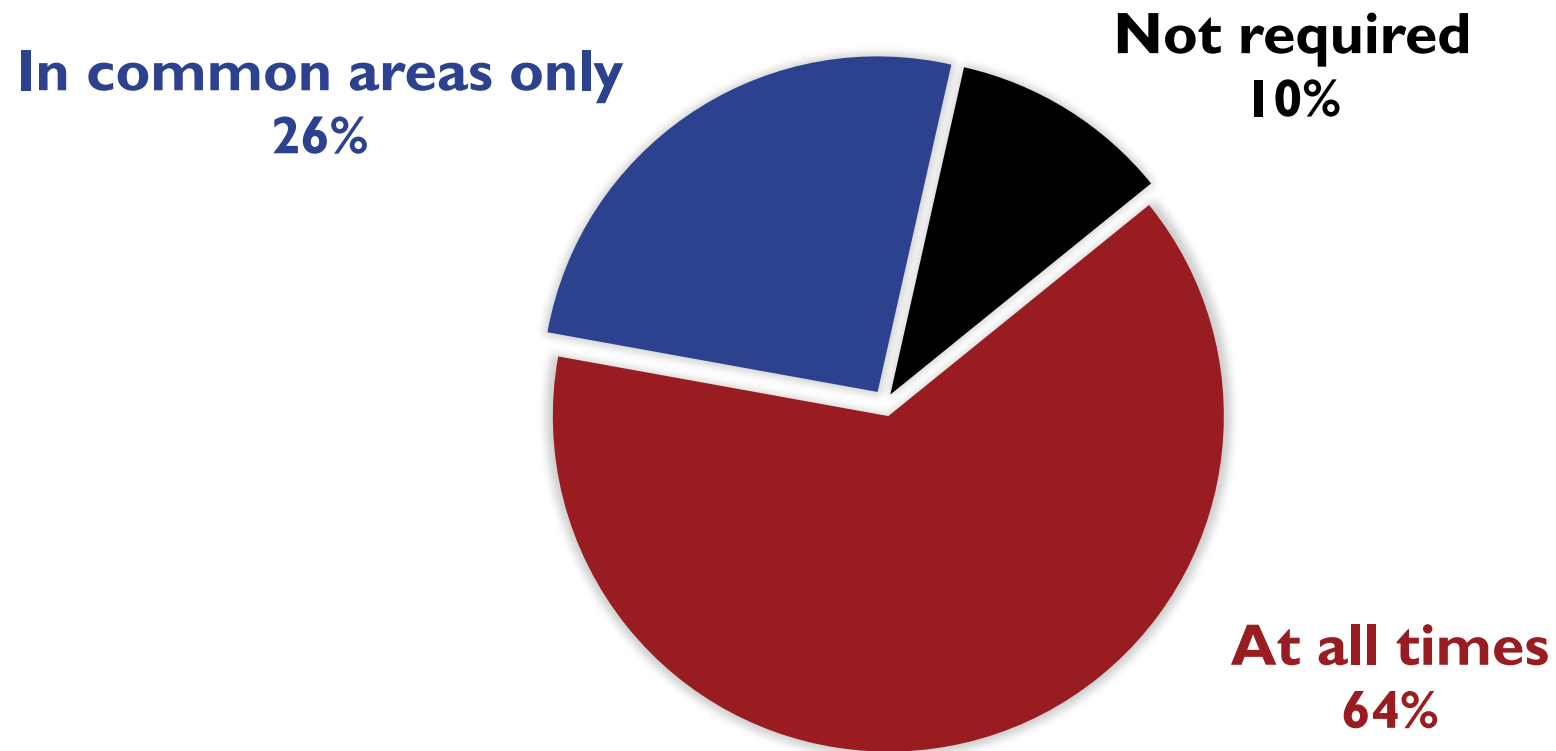

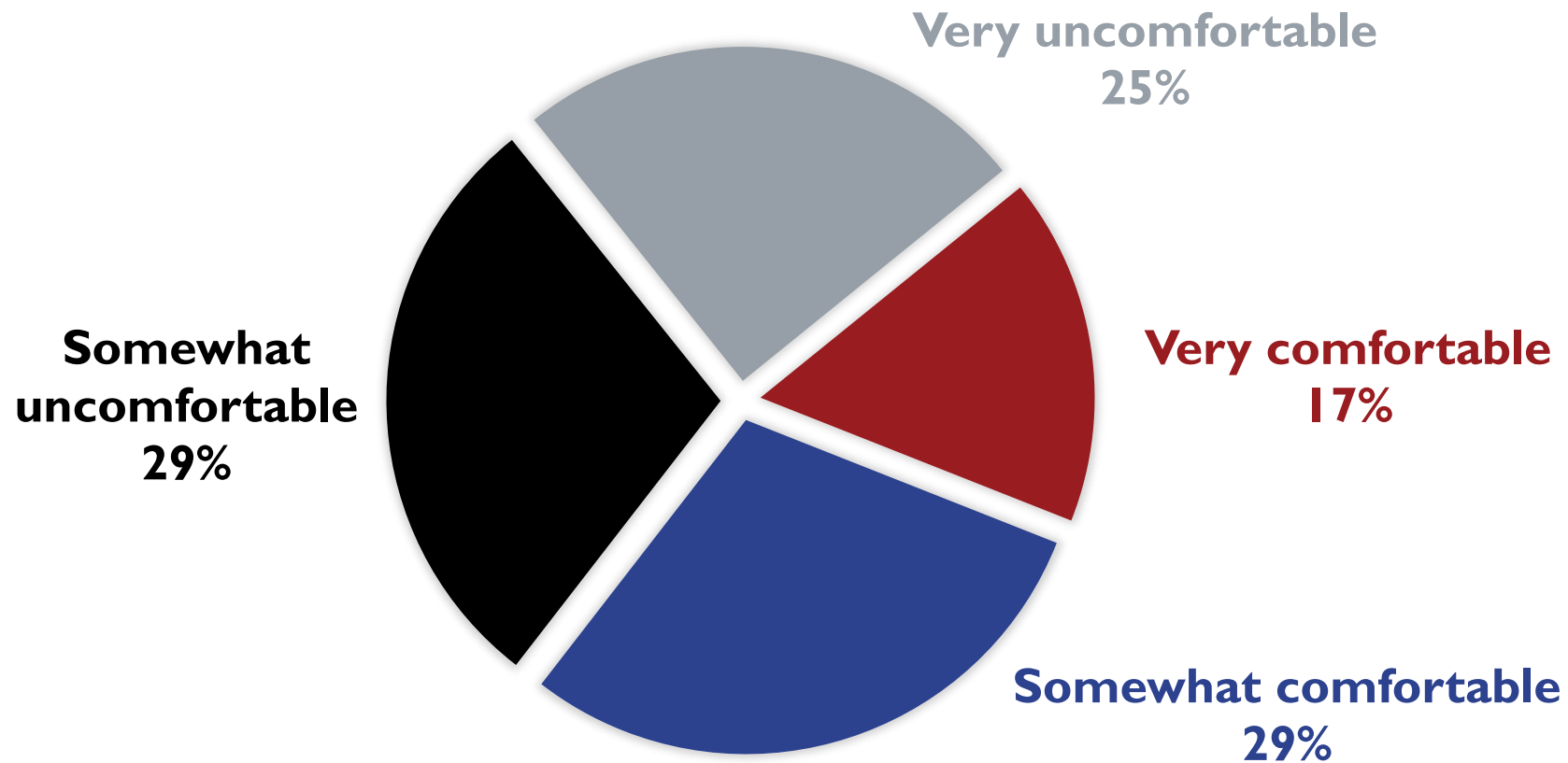

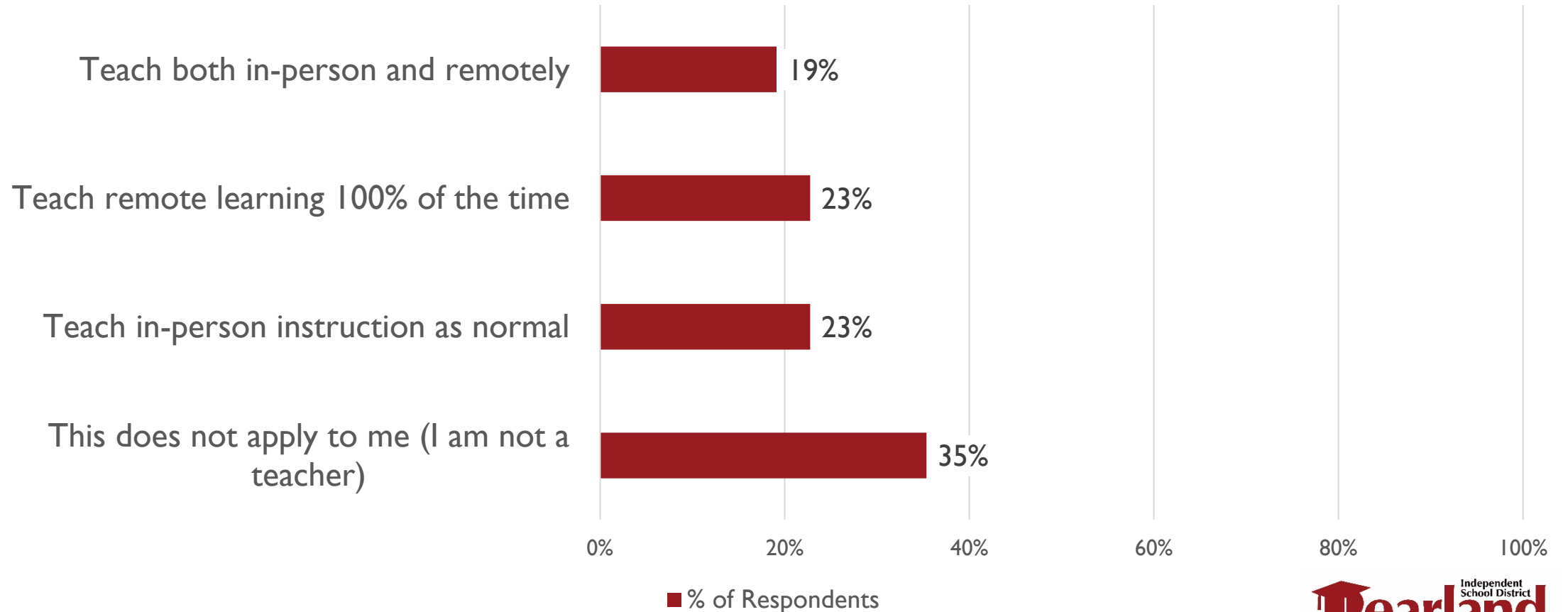
DO YOU THINK STUDENTS SHOULD BE REQUIRED TO WEAR MASKS?
