## REQUIREMENTS FOR GUARDIANSHIP BY POWER OF ATTORNEY

A *court ordered legal guardian* who the student lives with in Pearland ISD may enroll the student the same as a parent would, by providing the court order from a judge naming them a conservator or permanent legal guardian who has rights to determine residence of the student, and providing the other enrollment requirements. They will not need this process.

This process is for students who reside in someone else's home full time, separate and apart from their parent named on their birth certificate or apart from their legal guardian who is named on a court order as the legal guardian. There are eligibility requirements that the student must meet for this process. Certain disciplinary records, court records, or truancy may make a student ineligible.

The student is required to live with the guardian in the guardian's home full time at the time of application, sleep there each night and go to school from that home each day for the duration of the enrollment. The guardian will be considered the parent for the student and will be responsible for all matters pertaining to the student from enrollment to withdrawal, including but not limited to, attendance, punctuality, discipline, teacher meetings, transportation issues, illness, medical treatment, absence notes, truancy, grade reporting, student's class work, emergency notification, fees, fines, memberships and obtaining permission to attend field trips and other activities of the district. The parent will not manage the student.

Pearland ISD will verify the residence of students on guardianship. Pearland ISD must be notified immediately if the student moves from the guardian's home. It is a violation of Texas Education Code 25.001(h) and Texas Penal Code 37.10 for a person to falsify information on records for school enrollment. Any student found to be falsely enrolled will be immediately withdrawn and all parties will receive a fine for the period of ineligible enrollment. Violation of Texas Penal Code 37.10 also carries penalty under Texas law which Pearland ISD may pursue.

This guardianship may be revoked at any time by the parent named on the birth certificate of the student who has parental rights, a student's legal guardian with a court order who has rights to determine residence, or the guardian for school purposes. Any of those parties may revoke the guardianship by a notarized written statement when they withdraw the student.

Students enrolled under guardianship by power of attorney may be restricted by UIL rules for competition in sports or other extracurricular activities that are governed by UIL.

Who can complete a power of attorney to assign guardianship of a child to someone else?

- The parent named on the student's birth certificate who has parental rights. In the case of divorce, the parent named in a divorce decree who has the right to determine residence may assign guardianship to someone else.
- A person who is named on a court order as a legal guardian or has conservatorship of the child that includes the right to determine residence. That person must provide the court order showing their rights.

## ITEMS REQUIRED FOR GUARDIANSHIP PROCESSING

All of the following items/records are required to process guardianship.

- Notarized power of attorney from the parent on the student's birth certificate or from a person who is the court appointed legal guardian of the student if a legal guardian is appointing guardianship to someone else. Legal guardian must provide the court order naming them as legal guardian with rights to determine residence. (next 2 pages)
- Notarized application from the proposed Pearland ISD guardian to become the guardian for school purposes. (last 4 pages)
- Residence documentation for the guardian who the student lives with full time in Pearland ISD, in the guardian's name and address, includes all three items:
  - Deed or current lease (may use current tax record for deed)  
(Student must be listed as an occupant for multi family dwelling lease)
  - Current electric, gas, or water bill
  - Current Texas driver license or ID
- Student Records:
  - Legal birth certificate from Bureau of Vital Statistics (showing person giving guardianship of student as parent)
  - Court order if a legal guardian is giving guardianship to another person
  - Immunization record
  - Social Security Card
  - At the start of a new school year, the final report card from the previous school year is required (and transcript for students with credits from outside Texas Public Schools). Withdrawal sheet is required from previous school (and transcript for students with credits outside Texas Public Schools) for enrollment during a school year.
  - Discipline record for all of current school year and all of previous school year for all schools attended during that time frame.
  - Attendance record for all of current school year and all of previous school year for all schools attended during that time frame.

The following pages include:

- Two-page limited power of attorney to be completed and notarized from the parent on the student's birth certificate or from a legal guardian of the student if a legal guardian is assigning guardianship to someone else.
- Four-page application to become the guardian for school purposes, to be completed and notarized from the proposed PISD guardian.
